Assessment Development

Focus Statement

A journeyman Commercial Carpenter will have a general knowledge and understanding of:

- Print reading including an awareness of allied trades, basic construction math, and estimating and preparing takeoffs
- Layout including site and building control
- Framing wood, steel (non-welded) and interior/exterior finishes
- Concrete form work including ironworking/reinforcing steel and placing concrete
- Tenant finishout including doors/frames/hardware, cabinets, and trim
- Safety
